#### 1. Stakeholder Involvement

Reviewing your CPP activities in 2014, Please provide information about:

- What outreach and engagement activities did you carry out in 2014?
  - ➤ KIAA published and mailed a Spring Annual Meeting notice and Fall KIAA newsletter to over 550 residents.
  - ➤ KIAA continued support of its web site located at http://kenwoodminneapolis.org. The KIAA website revision is updated with announcements and e-newsletters.
  - As part of its community integration activities, KIAA held its Annual Meeting outdoors in the neighborhood business center. Child care and activities were provided by BeArtrageous. Bockley Gallery provided additional space in the event of inclement weather.
  - Residents were encouraged to sign up for NextDoor Kenwood an online neighborhood news site for residents to receive email news from KIAA.
  - Community involvement: KIAA placed an ad in Hill and Lake Press thanking past KIAA board members for their service to the neighborhood.
  - ➤ KIAA met with Peter Wagenius, Policy Director for Mayor Hodges, to discuss LRT in the neighborhood.
  - ➤ KIAA supported neighborhood activities through a donation to "Thrill Kenwood" to cover costs of the DJ/Sound Equipment and art activity stations for the community Halloween Party.
  - ➤ KIAA supported the Minneapolis Park and Recreation Board neighborhood activities through donations for outdoor summer movies and "Shakespeare in the Park" plays in Kenwood Park.
  - ➤ KIAA contracted with Preservation Design Works to assist KIAA with its role as a "consulting party" in the Section 106 review of the SWLRT.
  - ➤ KIAA supported the Kenwood Elementary School by contributing funds and helping to sponsor the Kenwood PTA Carnival.
  - ➤ KIAA 2014 CPP application was filed with the City of Minneapolis NCR.
  - ➤ KIAA provided financial support to the joint neighborhood Ice Skating Party on Lake of the Isles.
  - ➤ KIAA provided funding for increased police presence at East Cedar Lake Beach (Hidden Beach).
  - ➤ KIAA hired a consultant to help disseminate information to the Kenwood neighborhood through e-newsletters, mailed newsletters, and e-blasts.

- How did you reach out to and involve under-represented communities in 2014?
  - ➤ Kenwood has a small underrepresented community. We use print and electronic communications to reach all neighborhood residents and businesses.
- Did you find any strategies to be particularly successful? Why?
  - ➤ KIAA increased participation of the community at its Annual Meeting by holding the meeting outdoors in the business community. The neighborhood meeting attracted over 160 adults and children.
- What did not work so well? Why?
  - ➤ KIAA, despite its regular e-blasts and printed newsletters, has been unable to get a wider neighborhood participation on the Board and getting feedback on neighborhood issues.
  - ➤ KIAA's efforts to reduce the illegal and violent activity at East Cedar Lake Beach by providing funding for increased police presence was met with limited success. The consensus of the MPRB and the City of Minneapolis police is that the culture of the beach area needs to change in order to effect any significant change.
- How many people did you reach through direct contact (door knocking, meetings, one-on-ones, etc.)?
  - ➤ East Cedar Lake Beach Task Force meeting 60 residents
  - ➤ Southwest Light Rail Transit Town Hall Meeting 30 residents
  - ➤ Annual Meeting approximately 120 adults and 60 children.
- How many individuals volunteered in organization activities volunteered in organization activities?
  - Approximately 5 volunteers in addition to the KIAA Board members.
- How many individuals participated in your organization's activities?
  - Approximately 85 residents and community stakeholders attended the KIAA monthly meetings.
- How many people receive your print publications?
  - Approximately 550 residents receive the printed KIAA newsletter.
- How many people receive your electronic communications?
  - Approximately 300 residents receive the KIAA e-newsletter.

  - ➤ The illegal and violent activity at East Cedar Lake Beach during the summer months.

  - Recommendations of the Task Force were presented to the Minneapolis Park and Recreation Board to determine what short term strategies and actions could be set up in time for the summer of 2015.

  - ➤ KIAA encouraged rain garden participation in the Metro Bloom "Neighborhood of Gardens" program by applying for grants for ten rain gardens in cooperation with Conservation Corps and Minnehaha Watershed District.
  - ➤ KIAA was awarded with the American Planning Association (APA) plaque designating the Kenwood neighborhood as one of the top 10 Greatest Neighborhoods in the United States in 2013 under the organization's Great Places in America program.

  - Twenty residents have applied for the Metro Bloom rain gardens.
