Managed Community Gardens that have become a place for neighbors to connect over gardening

Increased Partnership, and moved into the building of Northeast College Prep, a new charter school in the area focusing on primarily East African students.

13. What more would you like to tell NCR or the community about your Stakeholder Involvement? What are you doing that is new or particularly successful to involve residents and others?

While our outreach capacities suffered greatly due to the loss of office space in March, and an inability to find space until September, we were able to continue our work in using Service Learners and Interns from the University of Minnesota. Our interns not only connect us directly to the University and allow us to keep up with current events regarding campus, but also allow us to connect with our student renter population in a much more meaningful way. Students in the neighborhood have responded much better to fellow students doing community-minded work in the neighborhood than they have to any other residents. Our internship program allows us to keep a finger on the pulse of the issues facing student renters in the neighborhood.

We also connect with neighbors in very meaningful ways through our events and gardens, as mentioned above. Hosting events (particularly the Como Cookout) allow us to connect with the members of our neighborhood that we normally do not reach, and our gardens are a draw not only for members of the community, but bring people from nearby neighborhoods and communities to our neighborhood as well.

We reformatted our biweekly e-newsletter to reach out to key community partners for news and information, rather than simply letting it come to the office, leading to much more information being shared with subscribers

We laid plans for 2017 to overhaul our way of communicating with our neighborhood, reaching out to our growing Somali population, restarting our paper newsletter, and to hire a Community Building Intern whose specific focus is to greatly increase our overall outreach

15. MAJOR HIGHLIGHT #1

Keeping the Organization Afloat

SECIA had major organizational shakeup in 2016. Both longtime staff members left the organization, and a new lead staff was hired. In May, we lost our longtime office space and went without an office space until September.

This loss of communications and organizational strife greatly affected our ability to let residents know about information that they may need or want to know, as well as our abilities to effectively reach out to the community

Despite very abrupt and unexpected changes and many interruptions in our normal communications, SECIA's Board and Staff worked together to stay afloat as an organization. We moved into a shared space with Northeast College Prep in September, were able to work with interns, host our normal set of events, and even were able recruit first-time board members at our election in November.

16. MAJOR HIGHLIGHT #2

Community Gardens

Our community gardens continued to thrive in 2016. Our native/pollinator gardens Talmage Crossing and Como Corner both added new plantings in 2016, and continued to draw a wide audience in the neighborhood to garden or even just to enjoy the purposeful addition of nature to our community. Talmage Crossing received a Metro Blooms Garden of Merit award for its exceptional attention to native plantings and maintenance.

Our food growing garden, Fairshare Farm had full membership and hosted several events centered around a community-funded and constructed bread oven. Construction on the Bread Oven was completed in the summer, and allowed our gardeners to host cooking events in the space, and has become a major draw to our area.
